

## **OFFICIAL RULES**

## NO PURCHASE NECESSARY TO ENTER OR WIN.

The Ultimate University of Elk Hunting Giveaway (the "Drawing") is open to legal residents of the 50 states of the United States of America and the District of Columbia, (collectively, the "USA") only. Entries received from outside the USA will not be considered. The Drawing is subject to all applicable federal, state, and local laws and regulations. Void in other countries, U.S. territories, and where prohibited or restricted by law.

**Eligibility**. The Drawing is open only to legal residents of the USA who are at least 18 years old at the time of entry (each, an "Entrant"). Employees of OutdoorClass and the Rocky Mountain Elk Foundation, their immediate family members (spouse, parent, child, sibling), and members of the same household are not eligible to enter. **Agreement to Official Rules.** By entering, Entrants agree to be bound by these Official Rules and the decisions of OC, which are final and binding in all respects relating to the Drawing. Winning a prize is contingent upon fulfilling all requirements set forth in these Official Rules.

How to Enter. Entries must be received between 12:00:00 a.m. Mountain Daylight Time ("MDT") on July 11, 2025, and 11:59:59 p.m. MDT on August 18, 2025 (the "Drawing Period"). OC's computer system is the official timekeeping device. Each additional form submission via the free method will count as one (1) additional entry, up to a total of fifteen (15) additional entries. Regardless of the method used, there is a limit of thirty (30) total entries allowed per person/email address. Any attempt to exceed this limit will result in disqualification of all entries from that individual

Methods of Entry (choose one or more):

- 1. **Online Sign-Up Entry (Default Method):** Complete the entry form accessible through links in official OC promotional emails or communications.
- 2. **OutdoorClass Website:** Visit the OC page titled *The Ultimate UEH Giveaway* and complete the entry form provided.
- 3. **Social Media Entry:** Access the entry form via links on official OC social media platforms (e.g., Facebook or Instagram).
